While this area was reserved for distribution to Virginia veterans Of the Revolutionary War who had served in the Virginia Continental Line and Virginia State Troops or their heirs, the area was opened to General settlement in 1797. Residents could purchase no more than 400 Acres and had to have occupied the land at least one year prior to making application. They were required to have improved the land by building a cabin or planting a crop. Until 1798 the grantee had to be 21 years of old; it was lowered to 18 in that year. Some of the patents in this series were well outside of the area with grants in Pendleton County being the most distant.

This land was purchased from the Chickasaw Indians in 1818 in what became known as the Jackson Purchase. A number of Revolutionary War veterans had been there without having clear title to their land so the General Assembly in 1820 advised them to do so immediately. The grants in the Jackson Purchase were offered for sale at a fixed price which in 1835 was 12½ per acre. There were 9,308 surveys. The grants date from 1820.

The first roll is the report of payments, which is headed "Col. John Logans Report of payments made by Green river setters [sic]" and includes page, date, name (chronological within first letter of last name, but there are multiple lists), number of acres, county, certificate number, payment amount, payment detail, and interest.

The second roll of film contains two indexes (there is nothing to indicate why there are two indexes).

The third roll has the records for 1796 in certificate-number order, but only provides the number, name, acres, county, and "situation" (usually the waterway).

The fourth roll is the Treasurer's records, recording payments chronologically, and gives date, name, acres, county, payment (pounds, shillings, pence), and certificate number.

The pension program for Confederate veterans or their widows began in 1912 in Kentucky. Applicants had to have been residents of the commonwealth since 1906. Widows had to have been married prior to 1890. A minimum of one year of military service was required. In later years the requirements were adjusted so that in 1942 a veteran could qualify if he had been a resident of Kentucky since 1915. There was a sliding scale for widows based on the date of their marriage to the veteran. All widows after 1952 were eligible.



Applicants had to demonstrate disability or financial need. They could own property worth no more than \$2,500 and could earn no more than \$300 per year. If a veteran lived in a Confederate home or had a wife who could support him, he was ineligible. The first roll is the index and consists of a single alphabet of veterans and widows. The name of the husband of the widow, the county of residence of the applicant, the date, the widow's maiden name, and the application number appear in the index. The records are arranged in numerical order. Application number 2389 follows application 4056; number 4651 is out of sequence at the end of the roll; and numbers 2866, 3016, 4252, 4631, 4632, 4633, 4635, 4636, 4638 to 4644, 4646 to 4650, 4652, and 4799 have been lost. Also missing from the microfilm are 26, 233, 303, 339, 374, 428, 3975, and 4838, but the originals are at the Kentucky Department for Libraries and Archives.

Abstracts appear in Stephen Douglas Lynn's *Confederate Pensioners of Kentucky: Pension Applications of the Veterans & Widows 1912–1946*, R929.3769/L989C/2000. Lynn also has listed the pensioners from each county of Kentucky. He does indicate is the pensioner was black, but there is no list of such individuals.
