The first series consists of about 15,920 documents selected from the files of the General Assembly and the Committee of the Pay Table by Sylvester Judd in the mid-nineteenth century. They are arranged in 37 volumes. There is an every-name index with every reference to an individual under his or her name. There are also entries to such subjects as estates and taverns. The compilers of the index did expand the names of individuals who were officers in the military, governmental employees, and prominent historical figures when their identities were clear.

There is no over-all index to the second series, but individual volumes have their own indexes. The third series has an over-all index.

This is one single alphabetical list for the entire state of probate papers deposited at the Connecticut State Library in Hartford. Most of the items are from the mid-1700s or later, as few of the first century of records survive as loose papers. Each card contains the name (of deceased or primary party), town, probate district, year, and number of documents of each kind: wills and codicils, bonds, applications and petitions, inventories, orders of court, returns to court, distributions, accounts of administration, receipts, and miscellaneous.

This work covers twelve years that are not featured in the entry above. Since the index does not include the years 1957–1967, the surname index in the above entry must also be used. For the years 1940–1956, this index is superior because it includes the forenames of individuals. There is also a date followed by the letter "m" for marriage date, "b" for birth date, "d" for death date, or "l" for lived in that time. Sometimes no date is reported because the query was so poorly worded that the indexers could ascertain no time frame.

# **Vital Records**

#### Barbour Collection of Connecticut Vital Records.

Lucius Barnes Barbour prepared one of the two most important manuscript collections about vital statistics for a Connecticut resident. The vital statistics were copied from town, church, and other original sources of the Nutmeg State. The work serves as a master index to vital records of Connecticut to the end of 1850. It is not, however, entirely complete. The original manuscript covers 137 towns and comprises 14,333 typed pages.

In 1644 the town clerk or registrar began recording births and marriages. The responsibility of deaths was added in 1650. A town will normally have few, if any, records before its incorporation. The introduction to the records of each town describes the records used to prepare the transcriptions. It is essential to know the parent town of each community in order to determine the correct individuals of the same name in an earlier jurisdiction encompassing the same vicinity.

The records of each town are in order by name of town, and thereunder by name of individual. Births, deaths, and marriages are interfiled in the same alphabetical sequence. Coverage for a town begins with the year the community came into existence as a legal entity. The births and marriages are indexed in the *International Genealogical Index*.

The following early towns were omitted from the Barbour index:

- Enfield, Hartford county, incorporated 1683 in Massachusetts but annexed to Connecticut in 1749. The vital records are included in Francis Olcott Allen's *The History of Enfield, Connecticut Compiled from All the Public Records of the Town Known to Exist, Covering from the Beginning to 1850, Together with the Graveyard Inscriptions and those Hartford, Northampton and Springfield Records Which Refer to the People of Enfield*, [microfilm, 3 rolls]

Mansfield, Tolland County, incorporated 1702 from Windham. These records are available in Susan W. Dimock's *Births, Baptisms, Marriages, and Deaths from the Records of the Town and Churches in Mansfield, Connecticut*, R929.3/D582B/1898.

New Fairfield, Fairfield County, incorporated in 1740

During the 1930s State Librarian Charles Hale oversaw the copying of more 1,000,000 cemetery inscriptions in more than 2,000 graveyards in Connecticut, arranged by town (rolls 319–374). Hale also directed that abstracts be prepared from the first ninety newspapers published in Connecticut (rolls 375–433).

There are several indexes: a general index to vital records (rolls 1–75), an index to deaths and inscriptions (rolls 76–232), an indexes to deaths in each newspaper (rolls 233–249), and an index to marriages in newspapers (rolls 250–318). While the indexes provide names and dates, the individual town or newspaper volumes will often give more data.
