The three-man board appointed by the President under the Act of April 16, 1862 examined petitions for compensation from former owners of slaves freed in the District. After 12 July 1862 slaves could present petitions if their owners had not already done so.

These records include emancipation papers for the period 1856–1863, manumission papers for the period 1851–1863, and case papers relating to fugitive slaves. The act abolishing slavery in the District of Columbia, passed 16 April 1862, required loyal owners of freed slaves to file schedules of their slaves in order to claim compensation. If an owner failed to file, a supplementary act of 12 July 1862 permitted schedules to be filed by slaves whose owners had neglected to do so. The act also granted freedom to slaves whose owners lived outside the District and who, with their owners' consent, were employed within the district.

The emancipation papers usually note when the certificates of freedom were issued. The manumission papers record the voluntary emancipation of slaves. Fugitive papers may contain warrants for arrests but some contain papers pertaining to proof of ownership.

Contrary to popular belief Black Americans in bondage did have and regularly used surnames, and they were typically not the surname of the family who owned them at the time of emancipation. The file of Elizabeth Abbot contains the names of the following eleven slaves with significant biographical details:

Matilda Sims, aged about 48 years, female, 5'4", dark brown color

Henry Sims, aged about 47 years, male, 5'9", sight in one eye injured, dark brown

James Sims, aged about 38, male, 5'5" about, dark brown

Charles Henry Ambush, aged about 36, male, 5'5", dark brown

Ellen Norris, aged about 45, female, 5'4", mulatto

Adel Francis Davis, twin, aged 22 years 6 months, 19 days, 5'2" about, dark brown, child of Ellen Norris

Catharine Ann Davis, twin, aged 22 years, 6 months, 19 days, 5', chestnut color, child of Ellen Norris

Indiana Davis, aged 20 years, 3 months, 18 days, 5'4" about, chestnut color, child of Ellen Norris Ellen Virginia Norris, aged 3 years, 5 months, female, chestnut color, child of Ellen Norris Joseph Davis, aged 4 years, 8 months, 23 days, male, bright mulatto, child of Catharine Ann Davis Cora Davis, aged 1 year, 8 months, 20 days, very bright mulatto, child of Catharine Ann Davis.
