They fled to Italy, Switzerland, Germany, Holland, Great Britain, Ireland, America, South Africa, Russia, Scandinavia, and the West Indies. Huguenots are also known as French, Flemish, Walloon, or Waldensian (Vaudois).

It should be noted that many individuals other than Huguenots also appear in these records since there are records such as naturalizations and denizations pertaining to all foreigners in English records.

Arabic numbers without any other symbol refer to pages in the respective quarto series. The index has converted Roman numerals to Arabic numbers followed by an asterisk. If no page number appears for a reference to a particular surname in a specific volume, that volume is already arranged in alphabetical order or it has its own index which will need to be consulted. The collection contains between six and seven million entries and is arranged in three series. Between twelve and fifteen per cent of the marriages from 1538–1837 are represented in the set. While no English county is complete, more than 4,300 parishes are included.

The main series has separate volumes for sixteen English counties. Each county is divided into ten periods 1538–1600, 1601–1625, 1626–1650, 1651–1675, 1676–1700, 1701–1725, 1726–1750, 1751–1775, 1776–1800, and 1801–1837. All counties, except Yorkshire, are indexed by both men and women.

The index gives the year of the marriage, the Christian and surnames of the parties, and the parish. Boyd adopted a single spelling for variations. For example, the surname of Wright is filed as though it were written Right. There are exceptions, however, to this rule.
